Blackstar Group Plc announces that today it purchased 840,000 ordinary shares of 67 pence each in the Company ("Ordinary Shares"), representing 1.1 per cent. of the Company's current issued Ordinary Share capital, in the open market into treasury at a price of 75 pence per Ordinary Share (the "Repurchased Shares").

The Repurchased Shares will be held in treasury for a short time until they are cancelled in the presence of a Luxembourg public notary for the purposes of Luxembourg law.

Once the Repurchased Shares have been cancelled, the Company's total issued ordinary share capital will consist of 75,821,193 Ordinary Shares.
